# **Activities and Events.**

**Resolution #1**. Moved Dr. Harker, Second Bob Volk to add a percentage cow/calf show at the National and Regional Classis levels.

- 1. Both cow and calf must be at least 50% Simmental. If either is not a purebred, then the pair is shown as a percentage.
- 2. Calf-at-side must be the cow's natural calf (no embryo transfer calves). This rule applies to all cow/calf competitions.
- 3. All regulations relating to the PB and Simbrah cow/calf competitions will be used for the percentage cow/calf competition.

Motion carried.

<u>Resolution #2</u>. Moved Dr. Harker, Second Jessie Driggers to change the age of the participating heifers showing at the National and Regional levels, from being born prior to January 1 to March 15 of the present year. This rule would then read that the participating heifers must be born after August 31, 2008 and prior to March 15, 2010. Motion carried.
