<u>Resolution #1</u> — Approve the request from the AJSA Board to invite Kyle Colyer of Idaho to serve as the cattle judge at the 2013 ASA National Classic in Lincoln, Nebraska.

<u>Resolution #2</u> — Based on AJSA Board recommendations, ASA make the following rule changes starting with the 2013 Regional and National Classic.

- a. In the judging contests, a standard be set of: Junior Division —1 set of reasons and 1 set of questions Intermediate Division – 2 sets of reasons Senior Division — 2 sets of reason and 1 set of questions; A comment or feedback system be added.
- b. In cattle division, AJSA members may exhibit up to 3 entries per show division, with the total maximum remaining at 3 entries total per exhibitor. For example, this would allow members to exhibit 3 purebred heifers or 3 percentage heifers, if so desired.
- c. Drop the National Skill-a-Thon contest.
- d. In the Cattlemen's Quiz contest, hard copies of *SimTalk* magazine are made available for use whenever Sire Summary questions are asked.

<u>Resolution #3</u> — Any AJSA Trustee not fulfilling the requirements of their signed contract may be removed from the Board. Trustees will receive a letter of warning stating that their fellow board members feel as if they are not fulfilling their duties as a trustee and if their involvement does not improve they will be asked to resign from their position.
