Policy & Procedures, Resolution #1 - THE Reporting. Moved Michael Stoltey, seconded John Harker to provide breeders, prior to the next enrollment period, with a list of cows previously enrolled in THE but have not reported calf data or reproductive codes. If calf data or reproductive codes are not sent in by January 15, 2008, then cows will be dropped from enrollment. To be reinstated in the THE program, breeders will have to pay \$35.00 per animal. Motion carried.

**d. Breed Improvement**. Michael Dikeman presented the report.

Items discussed:

Genetic Evaluation run with Guelph.

In-house run including tenderness Muscular fat for age Performance Advocate program

Breed Improvement, Resolution #1 - Discontinue Calculating Ratios outside normal age range. Moved Michael Dikeman, seconded Tommy Brown to direct the staff to discontinue calculating ratios for calves that are outside the age range for adjustment. Motion carried.

Reason: Ratios are currently calculated but are not used for genetic evaluation. This could make breeders become more vigilant about collect data within the appropriate age range.

Breed Improvement, Resolution #2 - Genetic Evaluation Contract with the Chinese Simmental Association. Moved Michael Dikeman, seconded Bobby Willis to develop a contract with the Chinese Simmental Association to run a genetic evaluation for minimum of \$3,000 per year for three years and that the Chinese Simmental Association would be charged for extra for ASA staff time that would be required to implement the contract. The American Simmental Association will only provide the Chinese Simmental Association with processed data. Motion carried.

Reason: There should be minimal staff time and expense in allowing use of our software and it brings in some income. It helps a developing beef industry in China and it could open the door for semen sales.

**Breed Improvement, Resolution #3 - Electronic Certificates**. Moved Michael Dikeman, seconded Jay Rinderknecht that ASA members have the option of checking a box to store registration certificates electronically and a drop down box would explain the options to members regarding transfers and paper certificates. Motion failed.

Reason: Storing registration certificates electronically will save considerable expense in mailing paper corticated to all members.

**Breed Improvement, Resolution #4 - Cow Awards**. Moved Michael Dikeman, seconded Jim Skillestad that only cows with 50% or more Simmental genetics and have an ASA registration number are eligible to received cow awards.

Reason: A significant proportion of the ASA Cow Award winners in the recent listing are purebred Angus or another breed and no percentage of Simmental genetics. The Breed Improvement committee believes that cows should have at least 50% Simmental genetics to be eligible for cow awards.

Moved Bob Volk, seconded Mike Mallet to amend the motion to remove 50% or more. Motion failed.

Moved Aaron Owen, seconded Van Neidig to table the motion and send back to committee to consider the effect on Simbrah and lower percentage Simmental. Motion carried.

**Executive Session**. Moved Michael Stoltey, seconded Mike Mallet to go into executive session. Motion carried.

Moved Jay Rinderknecht, seconded Tommy Brown to come out of executive session.
