- Zoning Commission scheduled for December 17, 2013.
- ➤ Due Diligence ends January 13. If all acceptable, close on January 14.
- Next Step: Survey and Site Plan Approval (may take up to 6 months to complete).

### Land Sell (Simmental Way). Report presented by Wade Shafer.

Items discussed:

- Counter offer sent to Edgemark at 12.5/sq. ft.
- Estimate \$4 million if accepts offer.
- No Response received back from Edgemark.
- ➤ Time frame for Edgemark's due diligence may take at least 6 9 months.

### R & D Development. Genetic Evaluation Update. Report presented by Wade Shafer.

Items discussed:

- Agreement to be finalized between ASA and Dr. Bruce Golden, and ASA and Dr. Dorian Garrick.
- ➤ Most likely a 2-year time frame beginning January 1, 2014.
- Resource allocations already in place.
- ➤ MCMC monte carlo/markov chain methodology will be used (method of choice for statistical applications with heavy computational demand).
- Enhance our ability to incorporate "outside" information (DNA & EPDs).
- Provide more flexibility in future development.
- Move toward long-term collaboration.
- Place us as the clear-cut leader in genetic evaluation ... across all species.
